The Vernon Parish Police Jury met in Special Session, Monday, September 13, 2010 at 4:45 p.m., in the Police Jury Meeting Room, with the following members present: Honorable James B. Tuck, President, Jackie Grimes, Vice-President, Pete Dowden, Tommy McMahon, Reggie Johnson, Jerry Blair, Leonard Johnson, Melvin Haymon, Curtis Clay, Joseph "Bo" Cryer and Kenny Haymon. **ABSENT:** Sam Fulton, Jr.

The invocation was given by Mr. Curtis Clay, and the Pledge of Allegiance was led by Mr. Melvin Haymon.

The Vernon Parish Police Jury was convened as the governing authority of the Parish of Vernon, by James B. Tuck, President, and was then ready for the business on the agenda.

A motion was made by Mr. Melvin Haymon, seconded by Mr. Reggie Johnson, to adopt a resolution in support of requesting assistance from the 2010-2011 Local Government Assistance Program (LGAP) for the following roads:

Mr. Sam Fulton, Jr., District 9 Juror, arrived at the meeting.


There was discussion on adding Lone Star Road, District 7 and Shadywood Drive, District 6 to the resolution.

President of the jury, explained that these two districts had been funded last year on this program, and this year districts that had not been funded would be eligible; was trying to be fair to all districts.


Mr. Leonard Johnson, District 7 Juror, objected to not adding Lone Star Road
