The road has been in the system for 1 year and continues to meet all the of Chapter 17 Section 23 of the Vernon Parish Code of Ordinances the road may be fully accepted into the Parish Road Inventory. This additional 960 feet will be added to the existing 814 feet, making Tilly Drive 1,774 feet long.
